Selection process and project implementation timeline:

- **31 July 2024:** Applications close
- **August – September 2024:** announcement and interviews of shortlisted schools/projects
- **October 2024:** announcement of successful grant recipients, sign Memorandum of Understanding and draft ICUP Action Plan
- **Term 4, 2024-Term 1 and Term 2, 2025:** implement and conclude the ICUP project in your school as per the Action Plan.
